

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

- WHEREAS**, the Tribal Council of the White Mountain Apache Tribe has been advised the Shelly Nashio has requested enrollment with the White Mountain Apache Tribe; and
- WHEREAS**, the Tribal Enrollment Committee has completely reviewed Shelly Nashio's enrollment application, and all supporting documents; and
- WHEREAS**, the Enrollment Committee finds that Shelly Nashio, whose birth date is August 17, 1974, possesses a blood quantum of one-half White Mountain Apache and four-fourths total Indian Blood; and
- WHEREAS**, the Enrollment Committee finds that Shelly Nashio meets the blood quantum requirements set fourth in the Constitution of the White Mountain Apache Tribe and is eligible for enrollment with the White Mountain Apache Tribe; and
- WHEREAS**, Shelly Nashio was enrolled from birth with the San Carlos Apache Tribe, until she relinquished her enrollment effective November 8, 1994; and
- WHEREAS**, Shelly Nashio has received a per-capita distribution under Court of Claims Docket 22-H, while enrolled with the San Carlos Apache Tribe; and
- WHEREAS**, pursuant to Resolution No. 04-96-085, which has been incorporated into the Tribe's 22-H Distribution Plan, Shelly Nashio would be ineligible to receive a distribution under the White Mountain Apache Tribe judgment under its Court of Claims Case Docket 22-H.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants Shelly Nashio's request for membership into the White Mountain Apache Tribe based upon the recommendation of the Tribal Enrollment Committee, and subject to rescission pursuant to the Tribal Enrollment Code, Sections 1-202 (c) and 1-704.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that pursuant to Resolution 04-96-085 and the Tribe's 22-H Distribution Plan, Shelly Nashio shall be ineligible to receive a distribution under Court of Claims Case Docket 22-H, due to Shelly Nashio's prior receipt of Docket 22-H funds while enrolled with the San Carlos Apache Tribe.




