

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** the Governing Body of the White Mountain Apache Tribe is the White Mountain Apache Tribal Council; and

**WHEREAS,** the White Mountain Apache Tribal Council is empowered by the Tribal Constitution and Election Ordinance enacted pursuant thereto, to declare that candidates for the office of Tribal Council have been regularly nominated and that each is a candidate for the office of Council member as indicated in the Nomination Petitions of said candidate; and

**WHEREAS,** the Tribal Election Commission on December 29, 1997 presented to the Tribal Council its Certification of Candidates qualified to be nominated for the office for which they sought, attached hereto and incorporated by reference herein; and

**WHEREAS,** on December 29, 1997, the Tribal Council reviewed the Certification of Candidates and agreed that each individual listed therein was qualified to be declared by the Council to have been regularly nominated as a candidate for the office of Council member for which he or she sought.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Certification of Candidates presented this date by the Tribal Election Commission as attached to this Resolution and incorporated by reference herein.

**BE IT FURTHER RESOLVED** by the Tribal Council that it hereby declares the following individuals as qualified and as regularly nominated for the respective office for which they seek:


