- WHEREAS, a Memorial Walk is scheduled at 10:00 a.m. on Friday, April 24, 1998 to honor victims of domestic violence and other crime related incident; and
- WHEREAS, the SPICE Committee requests that tribal employees wishing to participate in the `Memorial Walk be granted two hours administrative leave; and
- WHEREAS, the Tribal Council supports the efforts of the SPICE Committee and concurs that tribal employees should be granted administrative leave to participate in the Memorial Walk.
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants administrative leave from 10:00 a.m. to 12:00 noon on Friday, April 24, 1998 to tribal employees who participate in the Memorial Walk to honor victims of domestic violence and other related crimes.

The foregoing resolution was on April 20, 1998, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (s) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
