

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**WHEREAS,** the Tribe operates several programs providing social services and related assistance to Tribal members; and

**WHEREAS,** the Tribal Council would like to identify any duplication of those services provided by the Tribe and by federal and state agencies; and

**WHEREAS,** the Tribal Council has identified a Tribal member, Katy Aday, who has the skill and experience to review and coordinate the Tribe's Social Services Program, and to make recommendations to the Tribal Council concerning the effective management and control of the Program services; and

**WHEREAS,** Mrs. Aday is a career employee with the Indian Health Service; and

**WHEREAS,** under the Intergovernmental Personnel Act (IPA) Mrs. Aday could be detailed from the IHS to the Tribe to serve as an advisor and coordinator for the Tribal Social Services Program; and

**WHEREAS,** Mrs. Aday has expressed her interest in such an arrangement, the final of which would be subject to negotiation between the Tribe, IHS, and Mrs. Aday.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby requests that the IHS detail Mrs. Katie Aday to the White Mountain Apache Tribe under an IPA arrangement for a term of approximately two years to serve as an advisor and coordinator for the Tribe's Social Services Program.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that among her other duties as an advisor and coordinator, Mrs. Aday shall make recommendations to the Council concerning any unnecessary duplication of services, and advise the Tribe on which programs, if any, currently offered by the federal government would be advisable to be undertaken as a Tribal program through a 638 Contract.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that representatives of the Tribe and IHS meet together with Mrs. Aday, to negotiate the final terms of the IPA and report back to the Tribal Council for final approval.

The foregoing resolution was on May 13, 1998 duly adopted by a vote of eight for, one against, and one abstention by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (j), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
