- WHEREAS, prior to any funds being distributed to the White Mountain Apache Tribe Elderly Services Program, a spending plan and price quotation must be forwarded to the Inter Tribal Council of Arizona; and
- WHEREAS, the Elderly Service Program is in need of a van for the Cibecue Feeding Site to deliver meals and provide transportation to elders for shopping and for training and conferences; and
- WHEREAS, currently the Cibecue Feeding Site is using a 1986 Toyota van which is unsafe and has frequent breakdowns; and
- WHEREAS, a bid was received from Fuller's White Mountain Ford for a 1999 Ford Club Wagon 12 passenger van for a price of \$22,638.76 (attached hereto); and
- WHEREAS, Elderly Services is requesting that the Tribal Council approves a \$14,638.76 capital expenditure as matching funds to pay for the van.
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the capital expenditure of \$14,638.76 to go towards the purchase of a 1999 Ford Club Wagon 12 passenger van for the Elderly Services Program.
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the funds approved herein will be combined with the \$8,000.00 received from the Inter Tribal Council of Arizona, Inc., Area Agency on Aging to pay the full purchase price of the van.


