FORT APACHE INDIAN RESERVATION**

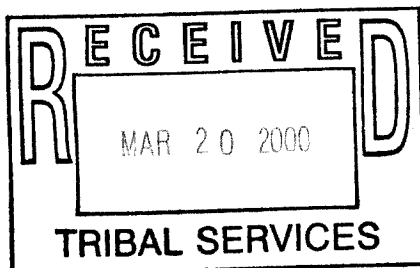
WHEREAS, the Tribal Council has the authority to appoint subordinate committees, commissions, boards, advisory or otherwise; and

WHEREAS, the Tribal Council has appointed new members (as identified per attached list) to the various committees and boards of the White Mountain Apache Tribe; and

WHEREAS, the Tribal Council concurs with the new appointments to the identified committees and boards.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves and appoints new members (per attached list) to the committees and boards of the White Mountain Apache Tribe.

The foregoing resolution was on March 01, 2000 duly adopted by a vote of FIVE for, THREE against, and TWO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (i), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
