

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Bureau of Indian Affairs, Fort Apache Agency, has furnished custodial and utility services at the Whiteriver Fire Management Center pursuant to a Memorandum of Agreement with the Tribe; and

WHEREAS, the Tribal Council is advised that said Memorandum of Agreement expired October 1, 1999; and

WHEREAS, the Bureau of Indian Affairs has submitted for approval a Memorandum of Agreement to continue providing custodial and utility services at this location for another term beginning October 1, 1999 and ending September 30, 2000; and

WHEREAS, the Tribal Maintenance Department has been provided an opportunity to assume custodial services at this location, and has agreed to accept this responsibility effective October 1, 2000; and

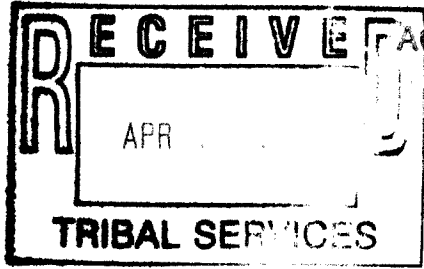
WHEREAS, the Tribal Council has considered this matter and believes it to be in the best interest of the Tribe to renew the Memorandum of Agreements with the BIA.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the renewal of the Memorandum of Agreement with the BIA Fort Apache Agency, for a term beginning October 1, 1999 and ending September 30, 2000, in the form attached hereto, for custodial and utility services to be performed at the Whiteriver Fire Management Center.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Maintenance Department will assume responsibility for custodial and utility services at the Whiteriver Fire Management Center effective October 1, 2000.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Chairman, and in his absence the Vice-Chairman or other duly authorized official, are hereby authorized to sign any and all documents necessary to carry out the intent of this resolution.

The foregoing resolution was on April 7, 2000, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1(a), (b), (e), (h), (j), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**MEMORANDUM OF AGREEMENT**

This agreement entered into between the White Mountain Apache Tribe and Bureau of Indian Affairs, Fort Apache Agency, designates the terms and conditions under which services at Whiteriver Fire Management Center, Whiteriver, Arizona are to be accomplished by Bureau of Indian Affairs and paid for by the White Mountain Apache Tribe.


1. In accordance with the Participation Schedule, the Bureau of Indian Affairs shall be reimbursed, not to exceed \$46,000.00, for custodial and utility services performed at the location designated herein. Payments will be made on a quarterly basis beginning on or about October 1, 1999.
2. On a quarterly basis, the Bureau of Indian Affairs shall submit to the White Mountain Apache Tribe an itemized invoice for payment.
3. Should there be a complaint of unsatisfactory service, the White Mountain Apache Tribe shall inform the Bureau of Indian Affairs Superintendent. The Bureau of Indian Affairs shall investigate the complaint and respond to the White Mountain Apache Tribe within two (2) weeks.
4. Reimbursement for the services identified herein shall be contingent upon the satisfactory performance of the services provided by the BIA, and subject to the Tribe's receipt of funding from GSA for said services.

This **MEMORANDUM OF AGREEMENT** shall be effective for a period beginning October 1, 1999 and ending September 30, 2000, subject to amendment by mutual consent and termination upon written request by either party.
