RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Maverick 3 Timber Sale is included in the ten year cutting budget in the 1991 2000 Forest Management Plan; and
- WHEREAS, the sale contract has been prepared without a unit specific residual value appraisal; but rather the contract is included in the formal annual reappraisal for the Ratio/Royalty Stumpage Valuation for Fort Apache Timber Company; and
- WHEREAS, the Maverick 3 Timber Sale is primarily in the Maverick Timber Management Area and is part of the annual allowable cut; and
- WHEREAS, the Reservation Lake Campground portion of the Maverick 3 Timber Sale is in the Hurricane Reserve Management Area; but has been included in this sale unit to accomplish recreation management goals of the White Mountain Apache Tribe on a singular case basis and that this action does not in any manner modify or rescind Resolution 11-94-337, which set aside separately the Hurricane Reserve Area from the Tribal commercial forest management base lands; and
- WHEREAS, the Tribe has an express desire to monitor erosion control re-vegetation treatments and the BIA will assemble an interdisciplinary team of both BIA and Tribal employees to do this monitoring according to protocol contained in the contract
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Maverick 3

 Timber Sale as presented in the proposed contract for the sale of timber, and subject to minor changes and administrative adjustments by the Approving Officer, be sold to the Fort Apache Timber Company as described below:

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman of the Tribal Council or his representative is authorized to execute the contract and related documents necessary to administer the sale of timber for and on behalf of the White Mountain Apache Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that deductions not to exceed thirteen percent (13%) of the gross receipts received from the Purchaser, will be accrued in the Road Suspense Account. This accrual will continue until the Road Suspense Account is funded to the extent required to provide the road construction fund reserve authorized by the Tribe.

The foregoing resolution was on <u>July 13, 2000</u>, duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (b), (f), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
