**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council this day has heard the request of Anderson Tullie of the Diné Tax Service of Chinle, Arizona to operate an individual income tax preparation service within the Fort Apache Indian Reservation; and

WHEREAS, Mr. Tullie has advised the Council that his focus in providing individual income tax preparation service to member of the White Mountain Apache Tribe is to give them honest and superior service and tax form preparation; and

WHEREAS, the Tribal Council finds that there is a need in the community for professional income tax preparation service and the Council, after hearing from Mr. Tullie, believes that his services are useful to member of the Tribe, especially those in the community of Cibecue; and

WHEREAS, upon learning Mr. Tullie's request for a building or place in which to conduct his service, the Council has advised Mr. Tullie to contact the White Mountain Apache Tribe Enterprise Director for further information; and

WHEREAS, Mr. Tullie shall be responsible for all applicable license, tax, and lease fees.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Mr. Anderson Tullie to operate the Diné tax service within the Fort Apache Indian Reservation for the tax season beginning December 20, 2000 and ending April 20, 2001.

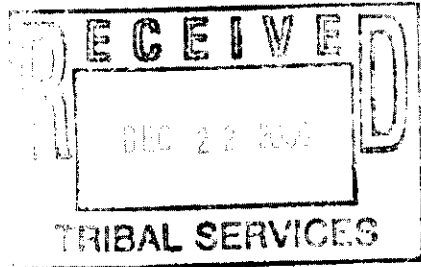
BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that this authorization for Mr. Tullie to conduct business within the exterior boundaries of the Fort Apache Indian Reservation is contingent upon his timely and satisfactory payment of all applicable license, tax and lease fees required to conduct business within the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that should Mr. Tullie locate a place suitable to conduct his service, he must obtain approval of the White Mountain Apache Tribe Enterprise Director and, if necessary, this governing body.

The foregoing resolution was on November 2, 2000 duly adopted by a vote of FIVE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in

it by Article IV, Section 1 (a), (b), (i), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
