FORT APACHE INDIAN RESERVATION**

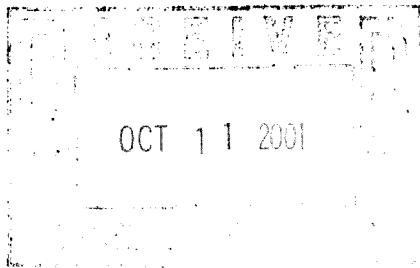
WHEREAS, by Resolution No. 03-99-49, the Tribal Council of the White Mountain Apache Tribe enacted the attached community street listing for the BIA road construction within the Fort Apache Indian Reservation; and

WHEREAS, the Tribal Transportation Committee and the Tribal Council of the White Mountain Apache Tribe wishes to amend the priority list to include granting the Right of Way and Temporary Construction Easement for the project titled FAIR Consolidated No. 25 consisting of the attached community street listing.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby amends Resolution No. 03-99-49 to include granting gratuitous Right of Way and Temporary Construction Easement to the Bureau of Indian Affairs for project titled FAIR Consolidated No. 25.



The foregoing resolution was on June 20, 2001 duly adopted by a vote of FIVE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (b), (h), (i), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
