

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, tribal members Gordon and Veronica Leslie, and Caryn Wagenfehr have current Residential Leases for their home sites located at Hondah A-8 and A-10, respectively; and

WHEREAS, Mrs. Wagenfehr and Mr. and Mrs. Leslie each wish to extend their property to include one-half of Lot A-9; and

WHEREAS, according to Tribal Realty records, Lot A-9 is vacant and available for assignment to a tribal member; and

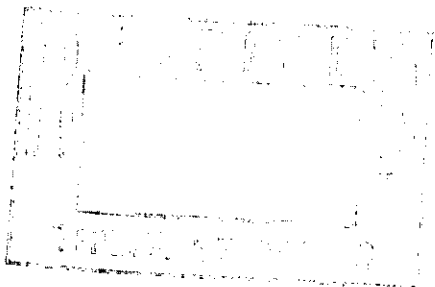
WHEREAS, the Tribal Council has considered this matter and concludes that permission should be granted to Mrs. Wagenfehr and Mr. and Mrs. Leslie to extend their property to include one-half of Lot A-9 each.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants permission to tribal members Gordon and Veronica Leslie, and Caryn Wagenfehr to extend their property to include one-half of Lot A-9 each.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Residential Leases between the Tribe and Gordon and Veronica Leslie, and the Tribe and Caryn Wagenfehr, shall be amended to include one-half of Lot A-9 each, respectively, and that the added portions of land shall be bound by and subject to all conditions governing the original Residential Leases.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribal Chairman, and in his absence the Vice Chairman or other duly authorized representative, to execute any and all documents necessary to carry out the intent of this resolution.

The foregoing resolution was on August 02, 2001, duly adopted for a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1(a), (b), (h), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
