WHEREAS, Mr. Fritz Walker, is a Tribal member with a disability and is employed with the White Mountain Apache Tribe Police Department as a dispatcher; and

WHEREAS, Mr. Walker has set goals for himself for an independent self-sufficient lifestyle and is seen as a role model to other disabled; and


WHEREAS, Mr. Walker has taught himself to operate a vehicle, has obtained an Arizona drivers license and drives himself throughout the community; and


WHEREAS, the Arizona Spinal Cord Injury Association donated a 1979 Ford Van, equipped with a wheelchair lift, to the Vocational Rehabilitation Program after which WMATVR and the State Rehabilitation Service Administration jointly worked together to repair the van and install a new engine, a transmission, hand controls, remote doors, and power seats; and

WHEREAS, the Tribal Council finds that Mr. Walker could make good use of the 1979 Ford Van.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby donates the 1979 Ford Van, VIN #1FDEE14N0KHA29467 to Mr. Fritz Walker.

The foregoing resolution was on December 20, 2001 duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
