

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council is advised that tribal member Bernadette Adley-Santamaria is requesting that her daughter, tribal member Michelle R. Tom, be included as a Lessee on her Residential Lease No. RFA-00-574 for Lots A-67 and A-68 in Hondah Homesites; and

WHEREAS, the Tribal Council has considered this matter and concurs with Ms. Adley's request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants approval of a Lease Modification to include tribal member Michelle R. Tom, as Lessee on Residential Lease No. RFA-00-574 for Lots A-67 and A-68 in Hondah Homesites.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribal Chairman, and in his absence the Vice Chairman or other duly authorized representative, to execute any and all documents necessary to carry out the intent of this resolution.

The foregoing resolution was on NOVEMBER 27, 2002, duly adopted for a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1(a), (b), (h), (i), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
