

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council of the White Mountain Apache Tribe (WMAT) recognizes many and varied forms of transportation services are needed within the Fort Apache Indian Reservation, such as development of public transit systems and roads development and maintenance; and


WHEREAS, there exist many programs and organizations on the WMAT Reservation providing some form of transportation activity; and


WHEREAS, there are resources and expertise available to support the development of a central information WMAT transportation services program which would consult with all tribal, state, and federal programs and organizations; and

WHEREAS, the Tribal Council acknowledges that it should support a single contact point for transportation needs of the White Mountain Apache Tribe.

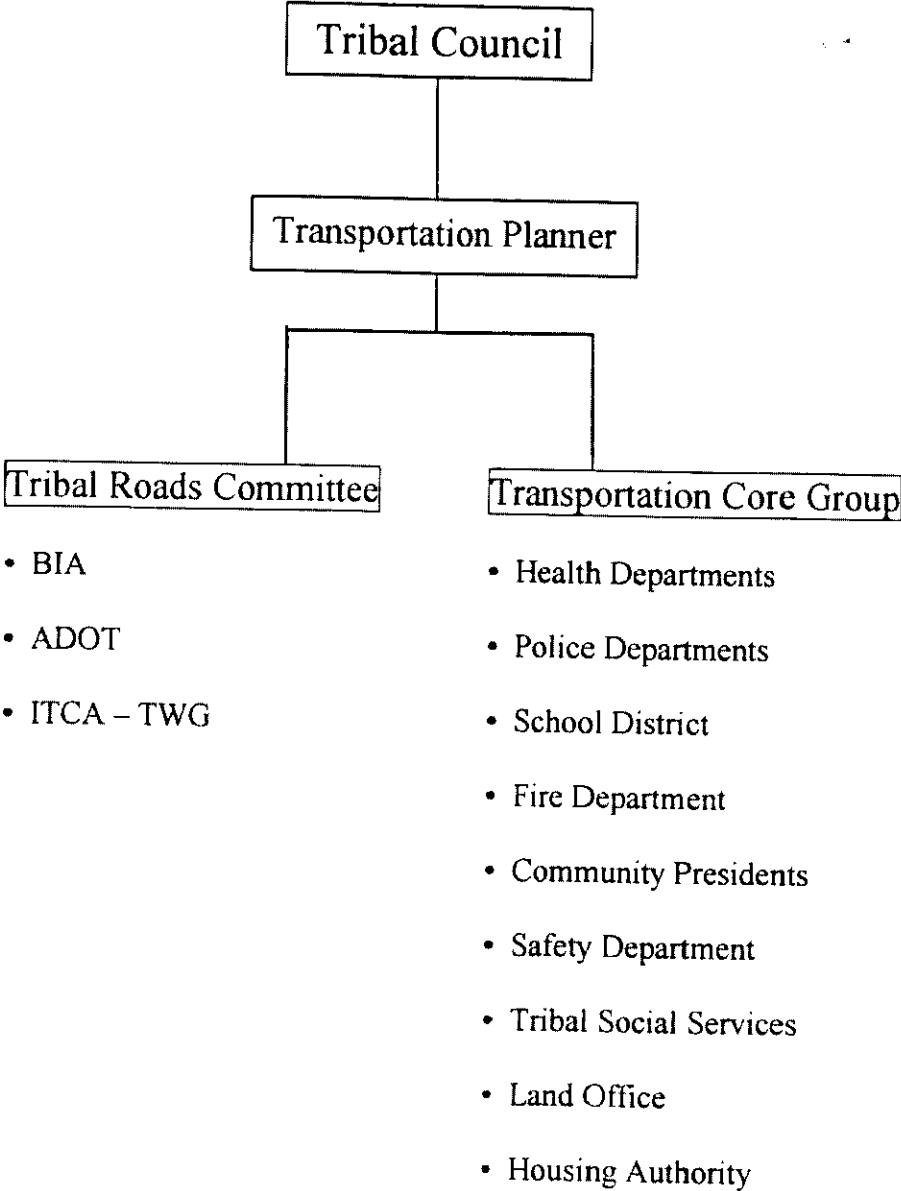
BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby designates Colbert Burnette as the main contact point for all public transportation needs of the White Mountain Apache Tribe.

The foregoing resolution was on December 5, 2002 duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

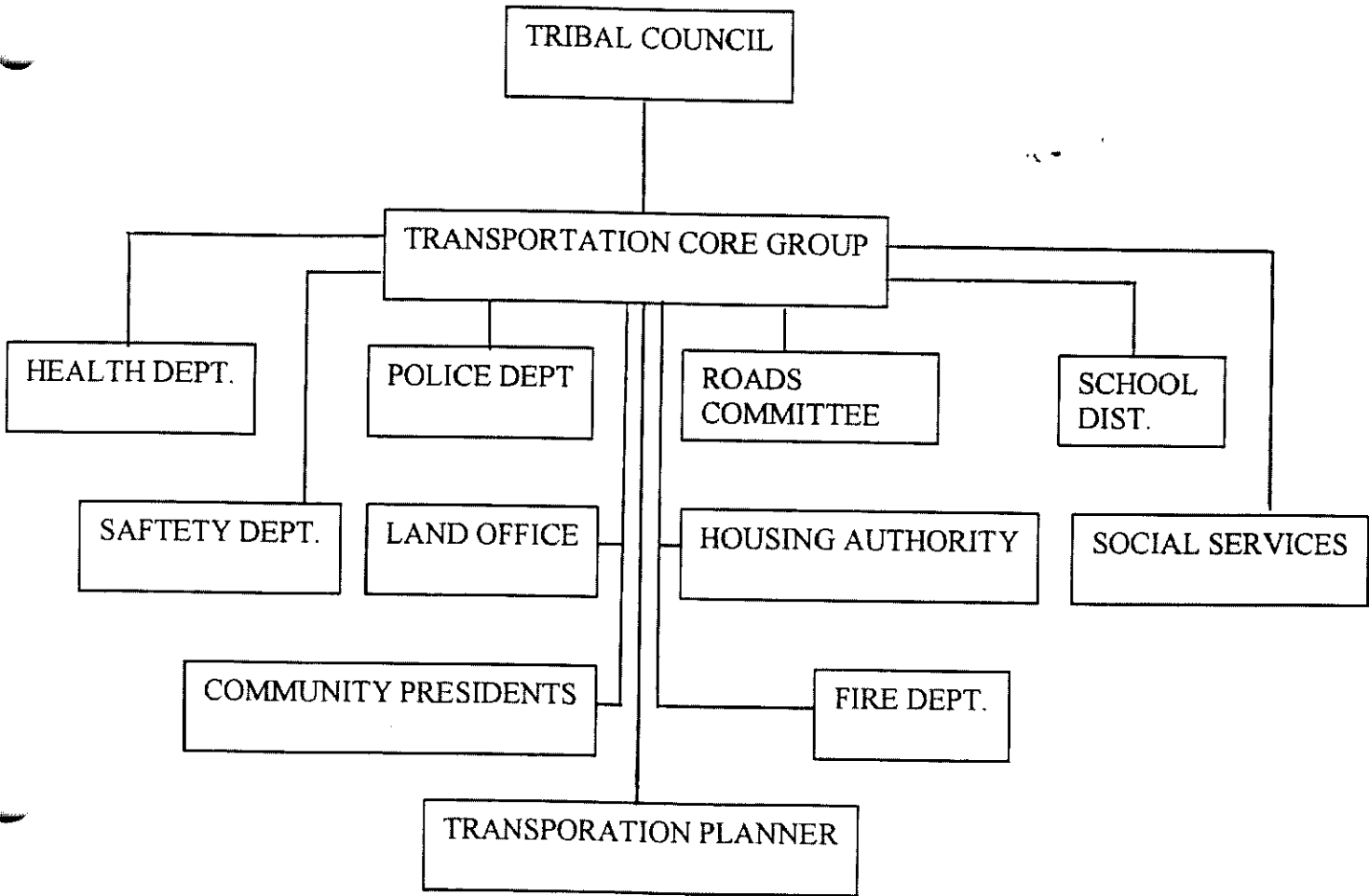
