

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, the Tribal Council is advised that Mr. Jimmy Silversmith, a resident of McNary and father of Tribal member Tracy Silversmith, passed away on June 16, 2003; and

WHEREAS, Mr. Silversmith is not a member of the Tribe, but as a resident of the Tribal community and father of a Tribal member, the family of the late Mr. Silversmith would like Tribal Council permission to bury his remains at the McNary cemetery; and

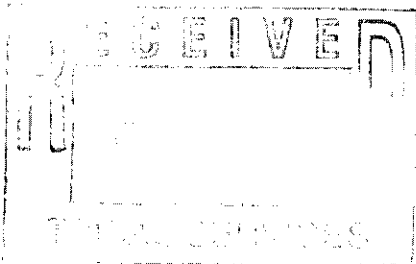
WHEREAS, other family members who are not members of the Tribe have been granted permission for burial at the McNary cemetery and a plot has been made available for Mr. Silversmith's remains; and

WHEREAS, Tribal member Colleen Altaha, the mother of Mr. Silversmith's child, also supports the request for the burial of Mr. Silversmith at the McNary cemetery; and

WHEREAS, due to the urgency of their request, with burial services scheduled for this Saturday, June 21, 2003, the Tribal Council is asked to authorize this request through a walk-through resolution.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the request by family members of the late Jimmy Silversmith that Mr. Silversmith be buried at the McNary cemetery.

The foregoing resolution was on 6-20-03 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (), (), (), (), (), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
