RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been advised that Albert Joe Standing, Jr. and Devine Rose Thomas have requested that their child Jalen Rose Standing's (dob: 3/28/99), enrollment with the White Mountain Apache Tribe be relinquished so he may become eligible for enrollment with the Navajo Nation.
- WHEREAS, Devine Rose Thomas signed the necessary documents of relinquishment of head rights for her child in the presence of a Notary Public on the 16th day of June, 2003, which is attached hereto; and Albert Joe Standing signed a notarized statement on June 30, 2003; and
- WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on June 30, 2003.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request for Jalen Rose Standing and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to: hunting, fishing, and recreational privileges upon the White Mountain Indian Reservation and upon Office of Vital Records' receipt of Proof of Enrollment with the Navajo Nation.
- **BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove Jalen Rose Standing from the membership rolls of the White Mountain Apache Tribe upon verification of his enrollment with the Navajo Nation.

The foregoing resolution was on August 19, 2003, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by the White Mountain Apache Tribal Constitution, including Article II, Section 2 and Article IV, Section 1 of the Constitution of the Tribe, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
