- WHEREAS, Mrs. Kessay currently leases a site within the Tribal Motel to operate a beauty salon, and is planning to develop the new site on which to relocate the business; and
- WHEREAS, Mrs. Kessay has obtained site approval from the Tribal Land Board, and Clearinghouse Level I approval from the Tribal Planning & Project Review (TPPR) Committee; and
- WHEREAS, the Tribal Council recognizes the benefit Mrs. Kessay's business has brought to reservation residents and also supports tribal member business ventures, and therefore, concurs with Mrs. Kessay's request.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves a 25-year business lease to tribal member, Fern Kessay, for the location identified in Exhibit A, for the development and transfer of her beauty salon business.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribal Chairman, and in his absence, the Vice Chairman or other duly authorized representative, to execute any and all documents necessary to carry out the intent of this resolution.

The foregoing resolution was on October 15, 2003, duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1(a), (b), (f), (h), (i), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
