FORT APACHE INDIAN RESERVATION**

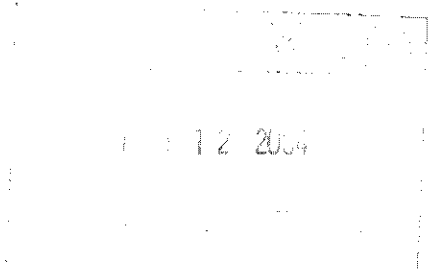


WHEREAS, Frances Ross Quesada was not a member of the Tribe; however, her great grandmother, Nannie Zahgotah was a Tribal Member; and


WHEREAS, due to the urgency of Ms. Nosie's request, the Tribal Council is asked to authorize this request through a walk-through resolution.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the request by Mary Lou Nosie and family members of the late Frances Ross Quesada that she be buried in Whiteriver, Arizona.







Chairman of the Tribal Council


