- WHEREAS, Frances Ross Quesada was not a member of the Tribe; however, her great grandmother, Nannie Zahgotah was a Tribal Member; and
- WHEREAS, due to the urgency of Ms. Nosie's request, the Tribal Council is asked to authorize this request through a walk-through resolution.
- **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the request by Mary Lou Nosie and family members of the late Frances Ross Quesada that she be buried in Whiteriver, Arizona.

The foregoing resolution was on <u>01/08/04</u> duly adopted by a vote of <u>SIX</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (), (), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
