FORT APACHE INDIAN RESERVATION**

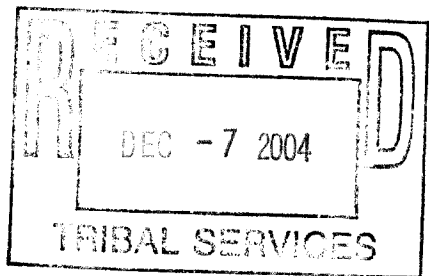


**WHEREAS**, Shayne Kris Hilton was not a member of the Tribe; however, he was married to tribal member Lucinda (Alsenay) Hilton and has children who are members of the Tribe. and


**WHEREAS**, due to the urgency of Mrs. Hilton's request, the Tribal Council is asked to authorize this request through a walk-through resolution.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the request by Lucinda (Alsenay) Hilton and family members of the late Shayne Kris Hilton that he be buried in McNary, Arizona on the Fort Apache Indian Reservation.

The foregoing resolution was on November 10, 2004, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).





