## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to grant tribal relinquishment request of Toya J'Shon Banashley)

- WHEREAS, Tribal member Toya J'Shon Banashley, date of birth: 02/08/1986, daughter of Phillip Banashley and Velinda (Manuel) Perry, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the Salt River Pima-Maricopa Indian Community; and
- WHEREAS, the necessary document of relinquishment of head rights was signed by Toya J'Shon Banashley in the presence of a Notary Public on the 2nd day of December 2004 and is attached hereto; and
- **WHEREAS**, the Tribal Enrollment Committee approved this relinquishment request at their meeting on December 10, 2004.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Toya J'Shon Banashley, and her tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation and upon the Office of Vital Records' receipt of Proof of Enrollment with the Salt River Pima-Maricopa Indian Community.
- **BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Toya J'Shon Banashley from the membership rolls of the White Mountain Apache Tribe upon written verification of her enrollment with the Salt River Pima-Maricopa Indian Community.

The foregoing resolution was on <u>December 14, 2004</u>, duly adopted by a vote of <u>EIGHT</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 2 and Article IV, Section 10f the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

I,, an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, do hereby of my own free will, as an adult over the age of 18 years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to remove me from the Tribal Census Rolls of the White Mountain Apache Tribe to enable me to enroll with the
Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be <b>TOTAL AND IRREVOCABLE</b> . I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
