

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving a business license, pesticide permit, and future business for Christopher Kane)**

**WHEREAS,** White Mountain Apache tribal members are entitled to preference in hiring and White Mountain Apache tribal member business owners are entitled to receive preference in receiving tribal contracts; and

**WHEREAS,** Christopher Kane is a member of the White Mountain Apache Tribe and currently owns his own pesticide company in Tucson, Arizona called "A Security Pest Control Company, and is licensed and bonded in the state of Arizona; and

**WHEREAS,** Christopher Kane would like to start his own pesticide company on the Fort Apache Indian Reservation to service tribal member homes, schools and other buildings, and he needs a tribal license to conduct business on the Fort Apache Indian Reservation and a pesticides permit issued by the White Mountain Apache Tribe's Hydrology and Water Resources Program; and


**WHEREAS,** the White Mountain Apache Tribal Council is interested in utilizing Christopher Kane to service its tribal buildings, provided this does not interfere or conflict with any contractual obligations the White Mountain Apache Tribe has with other third parties.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. A business license for Christopher Kane, for the sole purpose of providing pesticide treatment to dwellings and buildings located on the Fort Apache Indian Reservation, is hereby approved; and
2. The White Mountain Apache Treasurer's Office is ordered to issue such business license, provided Christopher Kane meet all applicable licensing and other tribal requirements; and
3. The White Mountain Apache Tribe's Hydrology and Water Resources Program is ordered to issue a tribal pesticides permit to Christopher Kane, provided he meet all applicable permit requirements; and
4. Christopher Kane receive tribal member preference in any tribal jobs requiring pesticide treatment, provided this does not interfere or conflict with any contractual obligations the White Mountain Apache Tribe has with other third parties, and provided that he receive his tribal business license and tribal pesticides permit; and
5. The Tribal Chairman, and in his absence, the Vice-Chairman, is hereby authorized to negotiate and execute an agreement with Christopher Kane necessary to implement the intent of this Resolution.

**Resolution No. 02-2005-23**

The foregoing resolution was on FEBRUARY 2, 2005 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (b), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
