


**RESOLUTION OF THE

FORT APACHE INDIAN RESERVATION
(Approval to grant non-member burial on F.A.I.R.)**

WHEREAS, the Tribal Council is advised that Shirley Yardley is requesting Tribal Council permission for her father, Robert Baylish, to be buried in Canyon Day, Arizona; and

WHEREAS, Robert Baylish was not a member of the Tribe; however, his grandchildren are Tribal Members and he was born and raised on the Fort Apache Indian Reservation.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the request by Shirley Yardley and family members of the late Robert Baylish that he be buried in Canyon Day, Arizona on the Fort Apache Indian Reservation.

The foregoing resolution was on February 16, 2005, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
