

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approval to grant tribal relinquishment request of Krystal Morning Star Hoskie)**

**WHEREAS**, Tribal member Krystal Morning Star Hoskie, date of birth: 03/28/1994, daughter of Peter G. Hoskie and Juanita (Wilson) Joe, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the Salt River Pima-Maricopa Indian Community; and


**WHEREAS**, the necessary document of relinquishment of head rights was signed by Juanita (Wilson) Joe in the presence of a Notary Public on the 19th day of January 2005 and is attached hereto; and

**WHEREAS**, the Tribal Enrollment Committee approved this relinquishment request at their meeting on April 6, 2005.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Krystal Morning Star Hoskie, and her tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Krystal Morning Star Hoskie from the membership rolls of the White Mountain Apache Tribe.

The foregoing resolution was on April 13, 2005, duly adopted by a vote of SEVEN for and ONE against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 2 and Article IV, Section 1 of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

FORM C RELINQUISHMENT OF TRIBAL HEAD RIGHTS CHILDREN WHITE MOUNTAIN APACHE TRIBE UNDER AGE 18 FORT APACHE INDIAN RESERVATION

OFFICE OF THE TRIBAL COUNCIL

I, JUANITA CHARLOTTE JOE the parent of our child who is an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, under the age of 15 years, do hereby, of my free will, as an adult over the age of eighteen years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, WHITERIVER, ARIZONA, to release my/our child from the Tribal Census Rolls of the White Mountain Apache Tribe to enable my/our child to enroll with the SALT RIVER P.M.A TRIBE.

Further, I understand that my child will no longer have fishing or hunting privileges on the FORT APACHE INDIAN RESERVATION; No home site or farmland assignments, or claim to have titles to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act.

Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the Resolution date accepting my child's relinquishment, any livestock in said child's name. I further understand, however, that my child may reapply for enrollment in the White Mountain Apache Tribe upon reaching the age of eighteen (18), but that the Tribal Council has total, nonreviewable discretion to deny or grant said reapplication.

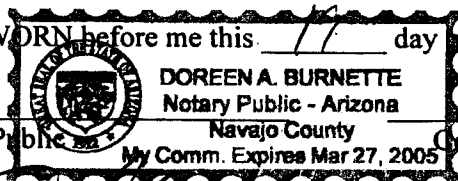
