

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approval of the Non-Tribal Member Hunting Regulations for 2005-2006)**

**WHEREAS**, the Tribal Wildlife & Outdoor Recreation Division has come before the Tribal Council this date and requested approval of the Non-Tribal Member Hunting Regulations for 2005-2006, copies of which are attached hereto; and


**WHEREAS**, the Tribal Council has reviewed recommended changes to the Non-Tribal Member Hunting Regulations designed to provide sustainable management of Tribal wildlife resources; and

**WHEREAS**, the hunting seasons, bag limits and regulations are based on sound biological principle, surveys and methods; and

**WHEREAS**, the Tribal Council concludes that the Non-Tribal Member Hunting Regulations for 2005-2006, as amended herein, be approved by the Tribal Council.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the attached Non-Tribal Member Hunting Regulations for 2005-2006, as amended herein.

The foregoing resolution was on APRIL 7, 2005 duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 (a), (f), (h), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

**Other Proposed Changes**

- Make all elk hunt applications available on-line.
- All elk hunt applications (general archery, raghorn archery, youth raghorn and west end depredation) will have the same date of availability and the same deadline to submit them.
- Temporary campgrounds will be established for the elk hunts in Units with few or no established campgrounds e.g., Units 3, 4, 9 & 11.
- These temporary campgrounds will be determined by the W&ORD and removed after the conclusion of the nonmember elk hunts.
