## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to grant tribal relinquishment request of Phillip Kenneth Mireau, Jr.)

- WHEREAS, Tribal member Phillip Kenneth Mireau, Jr., date of birth: 08/25/1965, son of Phillip Sr. and Eunice (Cromwell) Mireau, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the Lummi Nation; and
- WHEREAS, the necessary document of relinquishment of head rights was signed by Phillip Kenneth Mireau, Jr. in the presence of a Notary Public on the 4th day of May 2005 and is attached hereto; and
- **WHEREAS**, the Tribal Enrollment Committee approved this relinquishment request at their meeting on June 1, 2005.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Phillip Kenneth Mireau, Jr. and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to hunting, fishing, and recreational privileges upon the White Mountain Apache Indian Reservation.
- **BE IT FURTHER RESOLVED** by the Tribal Council that it hereby directs the Office of Vital Records to remove Phillip Kenneth Mireau, Jr. from the membership rolls of the White Mountain Apache Tribe.

The foregoing resolution was on <u>June 1, 2005</u>, duly adopted by a vote of <u>EIGHT</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article II, Section 2 and Article IV, Section 1 of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be TOTAL AND IRREVOCABLE. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE Act. Further, that I must remove from the Fort Apache Indian Claims Commission (90) days after the resolution date accepting my relinquishment, all my livestock and
