**WHEREAS**, the White Mountain Apache Tribe is preparing for another election; and


**WHEREAS**, it is customary at this period that all members of the Governing Body of the White Mountain Apache Tribe cease their local radio reports; and

**WHEREAS**, these radio reports will resume after tribal elections have been held.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that all radio reports for Chairman, Vice Chairman and Tribal Council cease until after the tribal elections.

The foregoing resolution was on December 8, 2005, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
