**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Authorizing the Transfer of Title of a Vehicle to the Chairman of the Tribal Council, Vice Chairman, and Council Members from District I, II, and IV)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, Chairman Dallas Massey, Sr., Vice-Chairman Frank Endfield, Jr., District I Council Member Jacob Henry, District II Council Member Phoebe Nez, District IV Council Member Mariddie Craig have a distinguished record of service on the Tribal Council of the White Mountain Apache Tribe; and

WHEREAS, the Council Members named herein were provided vehicles to fulfill their duties as members of the Tribal Council; and

WHEREAS, said vehicles were obtained through a municipal lease and option agreement between the Tribe and Lehigh Capital Access, Inc.; and

WHEREAS, the Tribal Council finds that in recognition of the outgoing Council Members' service to the Tribe their vehicles should be provided to them as gifts; and

WHEREAS, prior Resolution Nos. 06-2002-119, 04-2000-124 and 86-103 had previously authorized irrevocable conveyances of vehicles as gifts to previous Council members in honor and recognition of their services.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. Title to the certain tribal vehicles shall be transferred to Chairman Dallas Massey, Sr., Vice-Chairman Frank Endfield, Jr., District I Council Member Jacob Henry, District II Council Member Phoebe Nez, District IV Council Member Mariddie Craig.
2. The Controller is hereby authorized to remit the total balance due on said tribal vehicles to Lehigh Capital Access, Inc., the lessor, subject to available funds.
3. The Chairman, or in his absence the Vice-Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution, subject to review by the Legal Department.

The foregoing resolution was on April 25, 2006, duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
