

**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Budgets for Staff Salaries for the Offices of Chairman and Vice-Chairwoman)**

**WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, inter alia, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS,** the Chairman and Vice-Chairwoman have this day proposed staff salary expenditure budgets for Fiscal Year 2006-2007, as attached and incorporated by this reference; and

**WHEREAS,** both the Chairman and Vice-Chairwoman, having been recently elected are in a transitional period and have special needs for their Offices that cannot wait until the entire budget process is completed; and

**WHEREAS,** the Budget and Finance Committee have reviewed the proposed budgets and recommend their approval; and

**WHEREAS,** the Tribal Council finds that funding the proposed capital expenditure budgets are in the best interests of the constitutional obligations of the Offices of Chairman and Vice-Chairwoman, and the Tribe.

**NOW BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. The proposed staff salary budgets for the Offices of Chairman and Vice-Chairwoman for Fiscal Year 2006-2007, as attached and incorporated by this reference, are hereby approved.
2. The Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution, subject to review by the Legal Department as may be required.


