**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Authorizing Expenditure of \$2,000 in Funds for Raybin Beatty to Participate in Team Roping)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, Raybin Beatty, a member of the Tribe, together with his family, did this day request \$2000 in funds to participate in the U.S. Team Roping Championship on October 22, 2006; and

**WHEREAS**, Mr. Beatty requires the funding to cover expenses related to travel, meals and lodging; and


**WHEREAS**, the Tribal Council finds that Mr. Beatty's participation will represent the Tribe, and that such participation is in the Tribe's best interests.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. Expenditure of \$2,000 is hereby approved, which shall be made from the Tribal Contributions account.
2. The Chairman, or in his absence the Vice-Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on July 12, 2006, duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
