



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Business License for Rez Newz, owned and operated by Dewey Lupe, a member of the White Mountain Apache Tribe)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, the Tribal Council has the authority to issue business licenses, pursuant to the White Mountain Apache Business Code, Section 1.1 *et seq.*; and

**WHEREAS**, Dewey Lupe has this day requested a business license to operate Rez Newz, an Indian owned newspaper business, serving the Fort Apache Indian Reservation; and

**WHEREAS**, Mr. Lupe seeks to initiate his first printing by Wednesday, August 16, 2006; and

**WHEREAS**, Mr. Lupe's publishing deadline requires issuance of a business license before the next regularly scheduled meeting, necessitating consideration of this matter by the Tribal Council outside of its regularly scheduled meetings on an urgent basis; and

**WHEREAS**, the Tribal Council finds that issuance of a business license is in the best interests of Mr. Lupe and the Tribe.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. A business license for Rez Newz is hereby approved, pursuant to the White Mountain Apache Business Code, Section 1.1 *et seq.*
2. The Secretary of the Tribal Council and/or the Treasurer is hereby directed to issue said license in accordance with the provisions of the WMABC.


The foregoing resolution was on August 8, 2006, duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


