**RESOLUTION OF THE
WHITE MOUNTAIN APAPACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving Harrisen DeClay's request for financial assistance/scholarship in the amount of \$5,968 for his attendance at the World Harvest Bible College)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe is empowered to act in all matters that concern the welfare of the Tribe; and

WHEREAS, Harrisen DeClay is attending the World Harvest Bible College and has requested financial assistance/scholarship from the Tribal Council; and

WHEREAS, Mr. DeClay has requested \$5,968 to cover his fall 2006 tuition, meals, ministry trips, books, late registration fee, parking fee, miscellaneous fee, rent and other living expenses.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves Harrisen DeClay's request for financial assistance/scholarship in the amount of \$5,968 to cover his fall 2006 tuition to the World Harvest Bible College, meals, ministry trips, books, late registration fee, parking fee, miscellaneous fee, rent and other living expenses.

The foregoing resolution was on August 10, 2006 adopted by a vote of 6 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Sections 1(a), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


