**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Authorizing Vice Chairwoman Margaret Baha-Walker and Council Members to vote at NCAI)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, the Tribal Council has traditionally been a member of the National Congress of American Indians (NCAI); and


**WHEREAS**, payment of membership dues currently due will enable the Tribe to be credentialed as a member in good standing effective October 2006 to vote at the NCAI convention in Sacramento, CA from October 1 – 6, 2006; and


**WHEREAS**, the Tribal Council finds that Vice Chairwoman Margaret Baha-Walker and those Council Members attending the NCAI convention should represent the White Mountain Apache Tribe and that they should have the authority to vote at the NCAI convention; and

**WHEREAS**, the Tribal Council further finds it necessary to consider this Resolution outside of the regularly scheduled meeting of the Tribal Council, because of the concurrent timing of the NCAI convention.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Vice Chairwoman Baha-Walker and Council Members to attend the convention on behalf of the White Mountain Apache Tribe and enter the Tribe's votes and comments during the proceeding.







