



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving the Miss White Mountain Apache Tribe 2006-2007 budget)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, Marcilla Cruz, Miss White Mountain Apache 2006-2007, is in need of a budget to perform her duties as Miss White Mountain Apache; and


**WHEREAS**, the Finance and Budget Committee have recommended a budget in the amount of \$47,965.00 (attached hereto and made a part hereof) and is requesting that the Tribal Council approve the proposed budget; and

**WHEREAS**, the Tribal Council finds that the budget recommended by the Finance and Budget Committee for Miss White Mountain Apache 2006-2007 is in the best interest of the Tribe.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Miss White Mountain Apache 2006-2007 budget in the amount of \$47,965.00, to be utilized by Marcilla Cruz in the performance of her duties as Miss White Mountain Apache 2006-2007.

The foregoing resolution was on October 31, 2006, duly adopted by a vote of FIVE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (k), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
