Secretary took roll call at 9:11 a.m.

Pedro Johnson opened in prayer:

1. Ernie Curley – Requesting for land site in McNary near mother's resident (Lilly Curley). McDaniel stated that the land is available. Board approved the request.

2. Kino Kane – Requesting for farmland in Cedar Creek, has a relinquishment form, which was signed by Judy Declay. Board approved the request.

3. Cooper Tessler – Requesting for land site in Canyon Day, across from the Assembly of God Church, where he grew up and the people that live there are his relatives and told him that he can have the opened land there because no is living on it. The board suggested that McDaniel check into this by the next meeting in October. On Hold.

4. Jimmy and Beverly Thompson – Requesting for in land in Canyon Day near Jerome Kasey's resident, towards Bear Canyon. McDaniel show the committee a map of the area and those lots have not been allocated, but there is an area where they can request for not to far from that site. Mr. Thompson stated that that was fine. Board approved the request.

5. Felix Riley – Came before the board on concerns for his late unele's Nicodemus Riley's land in Canyon Day. Mr. Riley had gotten the house through court and papers on it to show that the property and belongings of the late Mr. Riley would go to him. Other family members are now harassing him for the lot telling him that the land is a family lot. The board put this on hold for Raymus to check into and will represent at the meeting in October.

6. Garry Thompson – Requesting for land in Canyon Day near Jerome Kasey's resident, he was told that in order for him to get land is to relinquish his other one. He wants to look into this lot first and McDaniel will show him. On Hold.

7. Rosie Gordon – Came into the board meeting on concerns of the lot in Canyon Day that Felix Riley had gotten. She believes that this lot was once their family lot, and that Mr. Riley has no business living there. She was upset because Mr. Riley is fixing up the property. The board members were shown a map of the area, and the map goes back to 1978, then the house was already built. She stated that this lot should be given back to her family. The board told her that they will have to wait off on it until Raymus and McDaniel go check into this matter. Justine told her that we would contact her through mail.

- 8. Rosalinda Endfield Applying for her late mothers land in Whiteriver. She was her mother's Guardianship and has documents on it. Board approved the request.
- 9. Bernie Minjarez and Patty Altaha on behalf of Behavorial Health Requesting for land in Cibecue near the fire station, but that land is not available was given to Elderly program. They were shown another part in Cibecue, which was available. Board approved this site.
- 10. Andrena Gordon Came before the board on concerns about the land that her parents had in East Fork, which now her brother lives. He is residing there and not allowing other family members. Also, concerns on the farmland in Corn Tank. Board suggested that she file this in court and find out whose names are on the lot. Board will have Raymus check into this. On Hold.
- 11. Kathy Skidmore and brothers and sisters Requesting for their late father Kinny Skidmore's farmland in Forest Dale. They stated that someone had put a lock on the gate entrance to the cornfield, and there are other fields that are there besides theirs and it also is a access for the Navopache Electric Company. They stated that as long as they can remember their Dad always planted there in Forest Dale, and now others want to use that land. Justin stated that he does remember a lot of the people that he plowed for during planting season. The board decided that the family should come back to next month meeting. On Hold.
- 12. Leon Peaches Requesting for land in Dry Valley, board disapprove due to Mr. Peaches having land already in McNary.
- 13. Limbert Quay Requesting for land in Cibecue, McDaniel will need to check into this. On Hold.
- 14. Cynthia Tessay Adgerson Requesting for land in Cibecue and relinquishing the one in Hondah back to Tribe. Ms. Adgerson stated that she is living in Cibecue and would rather have a land there to build on. Board approved the request.
- 15. Annalita Zahgotah Requesting for land in North Fork, behind the store. McDaniel stated that land is already taken. Board denied the request.
- 16. Diane Moody Requesting for land site in McNary, Board denied the request due to it being an industrial area.
- 17. Jovacka Sue Armstrong Requesting for land in Hondah lot #89. Board wants it check with Marco from Realty first.
- 18. Cornelia Hoffman Came before the board with concerns on some of the questions that the community members are asking her about sites and farmland. Requesting for land code so that she will get information from it.
