**(Approval of Land Board meeting minutes for November 30, 2006)**



Meeting opened in prayer at 9:20 A.M. by Pedro Johnson.

Board Members went into discussion on different issues concerning the Land Office. Justin request to have a special meeting sometime in January to cover concerns on the land code, applications and to meet with the Tribal Attorney on plans and with Byron McNeil on the location site for the Land Office, also plans with Housing and need of land sites. Secretary will set up date for the special meeting in January 2007.

Opened to the public:

1. Martinez Celaya - Requesting for landsite in McNary, where his house is located, the house was given to him through resolution by the Tribal Council. Raymus explain to him that the resolution is needed with the application. Mr. Celaya will bring these documents back to the meeting. Request on hold.
2. Lenora Kasey - Requesting for farmland that belong to Will Baha , this land was given to her and claims that her sisters approve of this request. Raymus suggest that she gets approval from the others by signing or writing a statement on her behalf. Request approved by Board and Ms. Kasey will bring the letters back with signatures.
3. Tim Clawson, Sr., - Requesting for site in Cedar Creek near his existing home, looked in his file and found that this land is already in his name and application on file.
4. Leon Peaches – Requesting for land in Hondah, Board ask for a letter from housing stating that he is no longer a tenant. Application on hold.
5. Orlando Carrol - Requesting for additional land to his present site in Hondah. He was told that he needed to get clearance from the Roads department, and he had spoke with Tom Thomas and was told that he had enough space for the addition. Board approved the request.
6. Bobby Billy Jr., - Requesting for land. Board disapproved due to application not being completed.
7. Noreen Wool – Applying for land in Whiteriver that was given to her by her father. States that her brothers and sisters are okay with it. Raymus suggest that she gets signatures from the other members. Will return at next month's meeting. Application on hold.
8. Lavenia Caddo – Requesting for landsite for her daughter Flavia Caddo, which is handicapped in China Town. Board approved the request. Also, relinquishing land site in Sawmill back to the tribe. Board approved.
9. Owen J. Laluk – Requesting for land in Hondah, needs to relinquish site back to tribe first.

17. Theresa Lee - Applying for landsite in Cibecue, near her daughters house, daughter was told that the area was being surveyed for the behavioral health office. Requesting for landsite across from the tire shop, McDaniel will check into this. Application on hold.
18. Michelle Nosie – Requesting for landsite in Hondah. Board approved the request.
19. Tennia Larzelere – Relinquishing landsite to Roy Quintero, Raymus will check this out. Application on hold.
20. Shenell Harvey – Requesting for landsite in Hondah, board approved the request.
21. Dempsey Quintero – Applying for farmland in East Fork, board would like for Cheryl Pailzote from Hydrology to check into this. Application on hold.
