**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Authorizing non-member (Richard DiValentino) burial on the Fort Apache Indian Reservation)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, Richard DiValentino, a member of the Hopi Tribe and husband of White Mountain Apache tribal member Arlene (Bones) DiValentino, recently passed away ; and


WHEREAS, Richard DiValentino has lived a long time in Ft. Apache where he and his wife raised their children and grandchildren; and


WHEREAS, Richard was employed with the White Mountain Apache Tribe at Fort Apache Timber Company for many years; and

WHEREAS, the family has requested that he be buried on the Fort Apache Indian Reservation at the Canyon Day Cemetery.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the request by the DiValentino family to bury Richard DiValentino at the Canyon Day Cemetery on the Fort Apache Indian Reservation.


