



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Emergency Assistance Expenditure of \$2,000.00 from Tribal Contributions for Council Member Evangeline Gatewood)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, members of the Tribal Council have requested emergency assistance in the amount of \$2,000.00 for Council Member Evangeline Gatewood, who will be hospitalized for surgery; and


**WHEREAS**, the Tribal Council finds that an expenditure of \$2,000.00 from the Tribal Contributions Account is appropriate and in the best interest of Council Member Evangeline Gatewood; and


**WHEREAS**, the Tribal Council agrees that an additional \$2,000.00 be deposited into the Tribal Contributions Account.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. The amount of \$2,000.00 is hereby appropriated for the purpose described herein, and said amount shall be deposited by the Treasurer into the Tribal Contributions Account and all budgets thereto shall be adjusted accordingly.
2. An emergency assistance expenditure from the Tribal Contributions Account in the amount of \$2,000.00 is hereby authorized for Council Member Evangeline Gatewood for the purposes described herein.
3. The Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.


