

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

## (Approving Emergency Assistance Expenditure of \$2,000.00 from Tribal Contributions for Council Member Wayne Colelay, Jr.)

- WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS, members of the Tribal Council have requested emergency assistance in the amount of \$2,000.00 for Council Member Wayne Colelay, Jr., who will be hospitalized for surgery; and
- WHEREAS, the Tribal Council finds that an expenditure of \$2,000.00 from the Tribal Contributions Account is appropriate and in the best interest of Council Member Wayne Colelay, Jr.; and
- WHEREAS, the Tribal Council agrees that an additional \$2,000.00 be deposited into the Tribal Contributions Account.

## BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

- 1. The amount of \$2,000.00 is hereby appropriated for the purposes described herein, and said amount shall be deposited by the Treasurer into the Tribal Contributions Account and all budgets thereto shall be adjusted accordingly.
- 2. An emergency assistance expenditure from the Tribal Contributions Account in the amount of \$2,000.00 is hereby authorized for Council Member Wayne Colelay, Jr. for the purposes described herein.
- 3. The Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>March 27, 2007</u>, duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
