



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Appointment of Permanent Land Restoration Board and Natural Resource  
Conservation District members)**

**WHEREAS,** pursuant to Article IV, Section 1(s), the Tribal Council has the authority to appoint subordinate committees; and

**WHEREAS,** the Tribal Council on April 8, 1998, enacted the White Mountain Apache Tribe Land Restoration Code, which provides for a seven member Land Restoration Board authorized to review and approve land restoration projects funded through the Land Restoration Fund; and

**WHEREAS,** Chapter 5 of the Land Restoration Code provides that the Board governing the management and operation of the district shall be the same board as the Permanent Land Restoration Board; and

**WHEREAS,** pursuant to Resolution No. 02-98-21, the Tribal Council created the White Mountain Apache Natural Resource Conservation District; and

**WHEREAS,** the Land Restoration Board recommends to the Tribal Council the following tribal members to fill the two vacant positions: Curtis Suttle Sr., from District III and Jerold Altaha, a young adult; and

**WHEREAS,** current Board Members include Levi Dehose District I, Cornelia Hoffman District II, Beverly Malone District IV, Paul Ethelbah Tribal Elder, and Cathy Tate having a college degree; and

**WHEREAS,** the Land Restoration Board request that all duties of the Coordinator and Conservation District Officer remain with Doreen E. Gatewood and continue to act as a liaison between the Board, the Tribal Council and the Tribal Planner as stated in the Code; and

**WHEREAS,** members of the Board request meeting pay for those meetings that occurred after adoption of the cost containment measures approved pursuant to Resolution No. 12-2006-423, and that said Resolution be amended or otherwise modified to allow payment.

**BE IT RESOLVED** by the White Mountain Apache Tribal Council that:


1. Jerold Altaha and Curtis Suttle Sr. are hereby appointed to the two vacant positions on the Land Restoration and District Conservation Board.

2. The current Board members are hereby re-appointed and shall continue to serve in their current positions.
3. Given the Board's eight years of service to the Tribe, the Board's request for meeting pay is hereby granted.
4. All duties of the Land Restoration Coordinator and Conservation District Officer for Natural Resource Conservation Service shall remain with Doreen E. Gatewood.

The foregoing resolution was on March 14, 2007 duly adopted by a vote of SIX for and TWO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (f), (g), (h), (k), (t), and (u), of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
