



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving the 2007 Apache Ceremonial Sunrise Dance Schedule)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council Secretary has received requests from tribal members and has prepared a schedule of Apache Ceremonial Sunrise Dances for 2007; and


WHEREAS, said schedule must be updated periodically for the benefit of the Sunrise Dance sponsors, co-sponsors and participants; and

WHEREAS, the attached Sunrise Dance schedule incorporated by reference herein is current to the date of this Resolution.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby declares the attached Sunrise Dance schedule as the official Tribal Council sanctioned 2007 Apache Ceremonial Sunrise Dance schedule for the White Mountain Apache Tribe to the date of this Resolution.

The foregoing resolution was on April 4, 2007 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
