



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approval of the Non-Tribal Member Hunting Regulations for 2007-2008)**

**WHEREAS,** the Tribal Wildlife & Outdoor Recreation Division has come before the Tribal Council this date and requested approval of the Non-Tribal Member Hunting Regulations for 2007-2008, copies of which are attached hereto; and

**WHEREAS,** the Tribal Council has reviewed recommended amendments to the Non-Tribal Member Hunting Regulations designed to provide sustainable management of Tribal wildlife resources; and

**WHEREAS,** the hunting seasons, bag limits and regulations are based on sound biological principle, surveys and methods; and

**WHEREAS,** the Tribal Council concludes that the Non-Tribal Member Hunting Regulations for 2007-2008, as amended herein, be approved.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the amended Non-Tribal Member Hunting Regulations for 2007-2008, as attached and incorporated by this reference, is hereby approved.

The foregoing resolution was on April 30, 2007 duly adopted by a vote of NINE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (f), (h), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
