

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

## (Requesting P.L. 93-638 Contract with U.S. Department of Interior for Certain Federal Programs)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache

Tribe, inter alia, the Tribal Council has the authority to represent the Tribe and act in

all matters that concern the welfare of the Tribe; and

WHEREAS, the White Mountain Apache Tribe has managed the following federal program pursuant

to a P.L. 93-638 (25 U.S.C. §450 et seq.) contract with the Secretary of the U.S.

**WHEREAS,** the Tribal Council finds that contracting for the foregoing programs pursuant to P.L. 96-638 is in the best interests of the Tribe.

## **BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

- 1. The Secretary of the U.S. Department of Interior, by and through the Bureau of Indian Affairs, is hereby requested to contract the federal functions identified herein, pursuant to the Indian Self-Determination and Education Assistance Act (P.L. 93-638, 25 U.S.C. §450, et seq.).
- 2. Said contract proposal should be in the form of an Annual Funding Agreement and Model Section 106 Master Contract, and should also include provisions for a two-year duration and increased funding by the BIA over and above its current commitment.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to negotiate, together with the 638 Negotiating Team, the Model 106 Contract and Annual Funding Agreement, and execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on July 12, 2007, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (c), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
