

Land Board Members present: Justin Williams, member: Pedro Johnson, Member: Emily Martine, Member: Bernice Caddo, Member: Rachel Endfield, Member: Elva Lomayaktewa, Secretary.

Bernice Caddo opened up in prayer at 9:20 A.M.

1. Thomas Edwards – Requesting for land in Seven Mile, near Hazel Tortice's residence. The Board approved the request. McDaniel will survey it for him.
2. Eunice Pinal/Jolene Pinal – Returned again for the cornfield in Whiteriver. Eunice stated that the Ethelbah family are putting up fence again and believe that they are fencing in that they are requesting for. Raymus stated that he did go there and saw that, and he informed the family that he is fencing in is not in Luther's name. Justin suggested that they take this to court to settle the situation. They have documents such as the will that court will base decision on.

5. Adrienne Colelay – Requesting for the Board to write a letter to Joaquin Garcia at the I.H.S Environmental to do assessment on the land in North Fork that was approved for her. She stated that she had received a letter stating that they could not test the area due to family dispute. The land is own by Kirby Coleleya and Adrienne would like to put a trailer on her lot but there is a lock on the gate to get to her lot. Board requested for her father Travis Colelay to come to the next meeting. On hold till then.
6. Geraldine Dehose/Jonus Dehose – Requesting for land in Cibecue for her parents, they will get a HIP house built for them but first they need land. She stated that her parents don't want to live anywhere else but Cibecue. McDaniel found an area for them. Board approved the request.
