



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Amending Resolution No. 11-2007-516 for the Purpose of Allowing Payroll Advances and  
Withholding Payroll Deductions)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, pursuant to Resolution No. 11-2007-516, "Re-Affirming Cost Containment Measures Under Resolution No. 06-2007-256," the Tribal Council did re-affirm cost containment measures for Fiscal Year 2007 instituted under Resolution No. 06-2007-256; and

**WHEREAS**, a request was made this day to amend Resolution No. 11-2007-516, in limited part, for the purposes of allowing payroll advances and withholding payroll deductions for the last pay period in 2007, known as payroll period number seventeen; and

**WHEREAS**, the Tribal Council concurs with the request, except that those legally required deductions (contractual, court order, child support and garnishments), housing payments and 401(k) loan payments should continue in full force and effect.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that:

1. Resolutions No. 11-2007-516 and No. 06-2007-256 are hereby amended in limited part to allow payroll advances and withholding payroll deductions for the last pay period in 2007, known as payroll period number seventeen, except for deductions legally required (contractual, court order, child support and garnishments), housing payments and 401(k) loan payments which shall continue in full force and effect.
2. The Controller is hereby directed to effect payroll advances and withholding payroll deductions as described herein.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on December 12, 2007, duly adopted by a vote of FIVE for and ONE against and ONE abstaining by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (k), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
