



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving Land Assignment for Rupert Lupe)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, on January 9th, 1990, Gertie Lupe, an enrolled member of the White Mountain Apache Tribe, had land assigned to her in District II of the Fort Apache Indian Reservation described as dry land located NW1/4; NE1/4 Sec 25 T 6 NR 20 E, totaling 0.93 acres in Cedar Creek; and

WHEREAS, Mrs. Lupe did this day express her desire to relinquish her land assignment and transfer it to her son, Rupert Lupe, also an enrolled member of the Tribe; and

WHEREAS, Mrs. Lupe wishes to undertake the request prior to the next regularly scheduled meetings of the Land Board and the Tribal Council; and

WHEREAS, the Tribal Council concurs with the request of Mrs. Lupe and finds that the land described herein should be transferred to Mr. Rupert Lupe; and

WHEREAS, given the urgency of Mrs. Lupe's request to transfer her land to her son, the Tribal Council further finds that the land transfer needs to be considered and made outside of its regularly scheduled meeting; and

WHEREAS, the Tribal Council further finds that: (1) this Resolution may be voted upon by signature of a member of the Tribal Council where a signature indicates a vote for this Resolution, (2) the Tribal Council Secretary should attempt to obtain signatures for members of the Tribal Council personally, (3) no signature would mean that the respective Tribal Council member is against this Resolution, (4) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. The title of Mrs. Gertie Lupe to the Land Assignment of January 9th 1990, as described herein, is hereby relinquished and transferred to Mr. Rupert Lupe.
2. The Land Board is hereby directed to record the transfer made herein.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that given the urgency of the request described herein, this Resolution may be voted upon as follows: (a) by signature of a member of the Tribal Council, including the Chairman of the Tribal Council and the


Vice-Chairwoman of the Tribal Council, where a signature indicates a vote for this Resolution, (b) the Tribal Council Secretary shall attempt to obtain signatures for members of the Tribal Council personally, (c) no signature shall mean that the respective Tribal Council member is against this Resolution, (d) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature, and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on December 6, 2007, duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (e), (h), (m), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






