

LAND BOARD MEETING MINUTES

1. Adrienne Colelay/ Kirby Colelay – Ms. Colelay requesting for land in North Fork at the Colelay's land assignment. The land is assigned to Kirby Colelay and he is not giving up any of the land to give to Adrienne, but he is willing to turn over the land that is in Diamond Creek behind the North Fork Store. He explained to the board that this land is originally a farmland not a home site, and wants to keep it that way, the late Pila Colelay gave him this land for him and his kids, and now he is requesting to put his children on with him on the application. Board approved the request. Ms. Colelay would like to see this area first before applying for it, will let the office know of her decision.
2. Ona Bush – Requesting for approval for relinquishment for Darrell Tenijieth to get land in Cedar Creek near Fritz Tenijieth Jr 's resident. She stated that her father had already agreed to give a piece of land to his grandson. Board approved the request for relinquishment and homesite.
3. Laura Melgar – Applying for land in Whiteriver near Eugene Cosay's resident which is being relinquish to her by Ona Bush. Board approved the request.
4. Buster Gordon – Requesting for land in to get HIP house built. McDaniel found a area for him in Six-pack, Fort Apache. Board approved the request.
5. Patricia James – Requesting to switch land in North Fork with her daughter Mitzi Bonito's land in Hondah. Board approved the request. She also would to put her name on her son's home site. Her son is deceased but he has two children she would like for the children to have his land when they are of age. The board agreed to put her name and the children's on the application. Approved.
6. Marie Aday – Requesting for land in East Fork behind her mother's resident. She stated that this land has been vacant all these years. McDaniel stated it was available. Board approved the request.
7. Ron Cordova – Requesting for land in Hondah, lot #65, called Cheryl Minjarez and she stated it was available. Board approved the request.
8. Simon Endfield – Applying for land in Cibecue to use for horse pasture and farmland near the Saw Mill and the school. On Map #1 is farmland #2 not available # 3 Horse pasture. He was told to ask Judy Dehose about the horse pasture. Board approved the request for #1, and #3 is on hold
