

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to grant tribal relinquishment request of Elliot Mark Pablo)

WHEREAS, tribal member Elliot Mark Pablo, dob: 03-05-1989, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the Gila River Indian Community; and

WHEREAS, the necessary documents of relinquishment of head rights was signed by Elliot Mark Pablo in the presence of a Notary Public on January 15, 2008, and are attached hereto and incorporated by this reference; and

WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on February 11, 2008.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Elliot Mark Pablo and his tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Office of Vital Records to remove Elliot Mark Pablo from the membership rolls of the White Mountain Apache Tribe, subject to proof of enrollment by the Gila River Indian Community within thirty (30) days of the date of this Resolution.

BE IT FURTHER RESOLVED by the Tribal Council that in the event that the Gila River Indian Community does not provide proof of enrollment to the Office of Vital Records, this Resolution shall be null and void and without force or effect.

The foregoing resolution was on March 17, 2008, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section II of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
