

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Authorizing reimbursement to Alvino Hawkins, Sr.)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache

Tribe, inter alia, the Tribal Council has the authority to represent the Tribe and act in

all matters that concern the welfare of the Tribe; and

WHEREAS, Alvino Hawkins, Sr., the Director of TERO, this day reported to the Tribal Council that

the TERO experienced a break-in on September 30, 2007; and

WHEREAS, although insurance covered the building, personal items were not, therefore, Mr.

Hawkins requests reimbursement in the amount of \$377.00 for loss of his personal

items which are itemized as attached an incorporated by this reference; and

WHEREAS, the Tribal Council finds that reimbursement to Mr. Hawkins is appropriate.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes reimbursement payment of \$377.00 to Alvino Hawkins, Sr. for personal items as attached and incorporated by this reference.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on April 10, 2008, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
