

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Ermon Colelay's Request for a Revolving Credit Loan)

WHEREAS, Ermon Colelay has applied for a tribal loan in the amount of \$19,150.00 from the Revolving Credit Program in order to construct an addition; and

WHEREAS, The loan application was presented to the Credit Committee at their meeting on March 14, 2008, after discussion the committee recommended approval; and

WHEREAS, The Plan of Operation for the Revolving Credit Program states in part 6, Section j,..." Committee members will not be eligible to receive loans from the Tribe during the time they are members of the Committee, unless their applications are approved by a majority vote of the Tribal Council of the White Mountain Apache Tribe..."; and

WHEREAS, The loan application requires Tribal Council approval because Ermon Colelay is a member of the Credit Committee for the Revolving Credit Program; and

WHEREAS, given the urgency of Ermon Colelay's request, the Tribal Council further finds that the request for the Revolving Credit application needs to be considered and made outside of its regularly scheduled meeting; and

WHEREAS, the Tribal Council further finds that: (1) this Resolution may be voted upon by signature of a member of the Tribal Council where a signature indicates a vote for this Resolution, (2) the Tribal Council Secretary should attempt to obtain signatures for members of the Tribal Council personally, (3) no signature would mean that the respective Tribal Council member is against this Resolution, (4) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the loan application submitted by Ermon Colelay is approved in the amount of \$19,150.00.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that given the urgency of the request described herein, this Resolution may be voted upon as follows:
(a) by signature of a member of the Tribal Council, including the Chairman of the Tribal Council and the Vice-Chairwoman of the Tribal Council, where a signature indicates a vote for this Resolution, (b) the Tribal Council Secretary shall attempt to obtain signatures for members of the Tribal Council personally, (c) no signature shall mean that the respective Tribal Council member is against this Resolution, (d) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature, and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.
